National Interest

RAINBIRD CRANE SERVICES shall be committed in all its actions to benefit the economic development of our country and shall not engage in any activity that would adversely affect such objective. It shall not undertake any project or activity to the detriment of the Nation's interests or those that will have any adverse impact on the social and cultural life patterns of its citizens. Public Representation of the Company

Shareholders

The Board of Directors of RAINBIRD CRANE SERVICES shall duly and fairly inform its shareholders about all relevant aspects of the Company's business and disclose such information in accordance with the respective regulations and agreements.

Ethical Conduct

Every employee of RAINBIRD CRANE SERVICES which shall include head of the company, shall deal on behalf of the Company with professionalism, honesty, integrity as well as high moral and ethical standards. Such conduct shall be fair and transparent and be perceived to be as such by third parties.

Every employee shall be responsible for the implementation of and compliance with the Code in his professional environment. Failure to adhere to the Code of

Regulatory Compliance

Every employee of RAINBIRD CRANE SERVICES shall in his business conduct, comply with all applicable laws and regulations, both in letter and in spirit, in all the territories in which it operates. If the ethical and professional standards set out in the applicable laws and regulations are below that of the Code, then the standards of the Code shall prevail.

Concurrent Employment

An employee of RAINBIRD CRANE SERVICES shall not, without the prior approval of the head of the company, accept employment or a position of responsibility (such as a consultant or a director) with any other company, nor provide "freelance" services to anyone. In the case of the head of the company, such prior approval must be obtained from the Board of Directors of the company.

Conflict of Interest

An employee of RAINBIRD CRANE SERVICES shall not engage in any business, relationship or activity that might detrimentally conflict with the interest of < Company Name >.

A conflict of interest, actual or potential, may arise where directly or indirectly:

- (a) an employee of RAINBIRD CRANE SERVICES engages in a business relationship or activity with anyone who is party to a transaction with his Company,
- (b) an employee can derive a personal benefit or a benefit to any of his relatives by making or influencing decisions relating to any transaction, and

(c) an independent judgment of the Company's best interest cannot be exercised.

The main areas of such actual or potential conflicts of interest would include the following

- Financial interest of an employee of RAINBIRD CRANE SERVICES or his relatives including the holding of an investment in the subscribed share capital of any company or a share in any firm that is an actual or potential competitor, supplier, customer, distributor, joint venture, or other alliance partner of the RAINBIRD CRANE SERVICES.
- An employee of RAINBIRD CRANE SERVICES conducting business on behalf of the Company or being able to influence a decision about the Company's business with a supplier or customer of which his relative is a principal, officer, or representative, resulting in a benefit to him or his relative.
- Award of benefits such as increase in salary or other remuneration, posting, promotion or recruitment of a relative of an employee of RAINBIRD CRANE SERVICES where such an individual can influence the decision about such benefits.
- Acceptance of gifts, donations, hospitality and/or entertainment beyond the customary level from existing or potential suppliers, customers or other third parties that have business dealings with the Company. Notwithstanding that such or other instances of conflict of interest exist due to any historical reasons, adequate and full disclosure by the interested employees should be made to the company's management. It is also incumbent upon every employee to make a full disclosure of any interest that the employee or the employee's immediate family, which would include parents, spouse, and children, may have in a company or firm which is a supplier, customer, distributor of or has other business dealings with his Company.

Every employee who is required to make a disclosure as mentioned above, shall do so in writing, to his immediate superior who shall forward the information

along with his comments to the person designated for this purpose by the head of the company who in turn will place it before the head of the company and/or the Board of Directors and upon a decision being taken in the matter, the employee concerned will be required to take necessary action as advised to resolve / avoid the conflict.

If an employee fails to make a disclosure as required herein and the management of its own accord becomes aware of an instance of conflict of interest that ought to have been disclosed by the employee, the management will take a serious view of the matter and consider suitable disciplinary action against the employee, including termination of employment and recovery of any damages.

Securities Transactions and Confidential Information

An employee of RAINBIRD CRANE SERVICES and his immediate family shall not derive any benefit or assist others to derive any benefit from the access to and possession of information about the Company, which is not in the public domain and thus constitutes insider information.

An employee of RAINBIRD CRANE SERVICES shall not use or proliferate information that is not available to the investing public, and which therefore constitutes insider information for making or giving advice on investment decisions on the securities of < Company Name Here > on which such insider information has been obtained.

Such insider information might include the following:

- Acquisition and divestiture of businesses or business units.
- Financial information such as profits, earnings, and dividends.
- Announcement of new product introductions or developments.
- Asset evaluations.

- Investment decisions/plan
- Restructuring plans
- Major supply and delivery agreement
- Raising finances.

Confidentiality on Salary and Compensation

Employees of RAINBIRD CRANE SERVICES shall not disclose their compensation package to anyone nor shall be permitted to discuss the compensation of any other employees to others.

Failure to adhere to the Code could attract the most severe consequences including termination of employment.

Protecting Company Assets

The assets of RAINBIRD CRANE SERVICES should not be misused but employed for the purpose of conducting the business for which they are duly authorised. These include tangible assets such as systems, facilities, materials, and resources as well as intangible assets such as proprietary information, relationships with customers and suppliers, etc.

Citizenship

An employee of RAINBIRD CRANE SERVICES shall in his private life be free to pursue an active role in civic or political affairs if it does not adversely affect the business or interests of the Company or the Group.

Integrity of Data Furnished

Every employee of RAINBIRD CRANE SERVICES shall ensure, always, the integrity of data or information furnished by him to the Company.

Reporting Concerns

Special Circumstance and Exception
Non-compliance and Consequence

Please find below the reasons that can lead to Termination of Employment. This list is non-Exhaustive

- Gross misconduct or behaviour that may result in disrepute to the employer.
- Misuse of office premises
- Misuse of assets made available for work
- Not disclosing to the management romantic relationship with a fellow staff member
- Wilful insubordination or disobedience, whether alone or in conjunction with another or others, or of any lawful or reasonable order of a superior. The order of the superior should normally be in writing.
- Going on illegal strike either singly or with other workers without giving 14 days previous notice.
- Abetment of or attempt at abetment of any of the above acts of misconduct.
- Threatening, abusing, or assaulting any superior or co-worker.
- Drunkenness, fighting or riotous, disorderly, or indecent behaviours while on duty at the place of work.
- Causing wilful damage to work in progress or to property of the employer.
- Conviction in any Court of Law for any criminal offence involving moral turpitude.

- Betting, gambling, and money lending business inside office premises.
- Preaching of or inciting to violence.
- Refusal to accept any charge sheet or order or notice communicated in writing.
- Any material or persistent breach of the terms contained in the contract.
- Disclosing to any unauthorised person of any confidential information regarding the working or process of the establishment which may come into the possession of the workman in the course of his work or even after exiting employment.
- Failure of Background check of Employment and Education qualifications.
- Habitual late attendance and habitual absence without leave or without sufficient cause.
- Continuous absence without information and without satisfactory cause for more than two days as per the policy of RAINBIRD CRANE SERVICES
- Habitual neglect of work.
- Habitual indiscipline.
- Any other reasons depending on the position occupied by the employee
- Failure to report any of the reasons mentioned above with respect to his / her reporting team members
